Scheer moved and Vorderstrasse seconded to approve changing Tuesday, March 20, 2018, to a day of no school for students and a teacher work day due to Meridian hosting MUDECAS Music West Division. Vote take: Scheer-aye, Bartels-aye, Sobotka-aye, Miller-aye, Vorderstrasse-aye, and VanWesten-aye. Motion passed 6-0.

Dewey Linnemann gave a presentation on FFA and the benefits of a program being started at Meridian. Mr. Linnemann answered the Board's questions following his presentation. Matt Kriefels from UNL will be attending the October Board Meeting to give the Board more information on the next steps to getting a program started.
